 Staff recommends approval of disbursements for the period beginning May 9, 2013 and ending June 12, 2013.

State Statutes require local governments to annually adopt an ordinance listing the prevailing wages for the Park District. Staff recommends that the Board adopt Ordinance No. 573 declaring the prevailing wage rates for the ensuing year to be the same as those fixed for Champaign County by the Illinois Department of Labor.

5. <u>Consideration of Approval Adopting Ordinance No. 574 Initiating the 2013A General Obligation Bond</u> Issue

Staff recommends adoption of Ordinance No. 574, An Ordinance authorizing the issuance of General Obligation Refunding Bonds (Alternate Revenue Source), Series 2013A, of the Champaign Park District, in Champaign County, Illinois, providing the details of such bonds and for alternate revenue sources and the levy of direct annual taxes sufficient to pay the principal of and interest of such bonds, and related matters.

 Staff recommends submitting an application for 2013 OSLAD funding for Douglass Park development.
 The application is due July 1, 2013.
