#### **PUBLIC HEARING**

The Champaign Park District Board of Commissioners held a Public Hearing on Wednesday, November 10, 2021 at 7:00 p.m. at the Bresnan Meeting Center, 706 Kenwood Road, Champaign, Illinois, and also online due to President Miller's determination that an in-person meeting or a meeting conducted pursuant to the Open Meetings Act was not practical or prudent due to the COVID-19 disaster. The Public Hearing Meeting occurred pursuant to published notice duly given. President Miller presided over the meeting. The ten individuals identified below were physically present at the meeting with appropriate social distancing. ### **Treasurer's Report**

#### Champaign Parks Foundation

President Miller reported that the Parks Foundation is supporting the Park District's Holiday Lights Show at Prairie Farm which opens on November 27, 2021. He stated that Foundation Directors are hosting a hot chocolate booth to promote the efforts of the Foundation. He welcomed participation by the Board and staff.

### Report of Officers

#### Attorney's Report

Attorney Hall reported that he is working on several ongoing matters. He outlined the most recent discussions with IDNR related to the OSLAD grant at Human Kinetics Park. Discussion ensued related to the timeline and cause of action.

#### Approval of Disbursements

President Miller opened the floor to questions or comments from Board members related to the list of disbursements.

Discussion and clarifications ensued regarding accounting terminology.

Vice President Hays made a motion to approve the list of disbursements for the period beginning October 13, 2021 and ending November 10, 2021. The motion was seconded by Commissioner Kuhl. Upon roll call, the vote was as follows: President Miller – yes; Commissioner McMahon – yes; Vice President Hays - yes; Commissioner Kuhl – yes; and Commissioner Solon – yes. The motion passed 5-0.

### Approval of Adoption of Ordinance No. 654: Tax Levy Ordinance

Ms. Wallace reported that the Board passed a resolution at its Regular Board meeting on October 13, 2021 to give public notice and hold a public hearing on November 10, 2021 regarding its intent to adopt a tax levy. Public notice was posted in the News-Gazette and on the Park District's website. Ms. Wallace also stated that the tax rate will not exceed 0.7279 and the amount extended will not exceed \$14,656,987.

Vice President Hays made a motion to adopt Ordinance No. 654: An Ordinance to Levy Property Taxes in the amount of \$14,656,987 for fiscal year beginning May 1, 2022 and ending April 30, 2023. The motion was seconded by Commissioner McMahon. Upon roll call, the vote was as follows: Commissioner Kuhl – yes; Vice President Hays – yes; Commissioner Solon – yes; President Miller – yes; and Commissioner McMahon – yes. The motion passed 5-0.

### Approval of Adoption of Ordinance No. 655: Bond Ordinance

Staff recommended Adoption of AN ORDINANCE AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION PARK LIMITED BONDS, SERIES 2021, OF THE CHAMPAIGN PARK DISTRICT, CHAMPAIGN COUNTY, ILLINOIS, AND PROVIDING THE DETAILS OF SUCH BONDS AND FOR THE LEVY OF DIRECT ANNUAL TAXES TO PAY SUCH BONDS, AND RELATED MATTERS.

Vice President Hays made a motion to adopt Ordinance No. 655: Adoption of AN ORDINANCE AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION PARK LIMITED BONDS, SERIES 2021, OF THE CHAMPAIGN PARK DISTRICT, CHAMPAIGN COUNTY, ILLINOIS, AND PROVIDING THE DETAILS OF SUCH BONDS AND FOR THE LEVY OF DIRECT ANNUAL TAXES TO PAY SUCH BONDS, AND RELATED MATTERS. The motion was seconded by Commissioner Solon. Upon roll call, the vote was as follows: Commissioner Solon – yes; Commissioner McMahon – yes; President Miller – yes; Vice President Hays – yes; and Commissioner Kuhl - yes. The motion passed 5-0.

### Approval of Bids for 2022 Bedding Plants

Mr. Olson reported that the average cost per flat had dramatically increased the previous year due to a number of factors. In 2022, staff reorganized their plans and were able to scale down the number of flats and also eliminate vegetatively propagated plants to reduce expenses by seven percent (-7%). Mr. Olson stated that the bid for bedding plants had been sent to fifteen (15) greenhouses and many chose not to bid due to capacity and shipping concerns.

Discussion ensued related to the number of flower beds, labor allocations, and payment due dates for flower island sponsorships.

Vice President Hays made a motion to accept the bids and authorize the Executive Director to execute contracts to purchase 2022 bedding plants for each order to the respective lowest responsible bidders as follows: park flower program order with 2,035 flats to Ropp's Flower Factory for a total of \$45,563 and flower island order with 1,651 flats to Connie's Country Greenhouse for a total of \$43,313. The total cost of the two recommended orders for 2021 will be \$88,876 with funds allocated in the FY22-23 operating budget. The motion was seconded by Commissioner McMahon. Upon roll call, the vote was as follows: President Miller - yes; Commissioner McMahon – yes; Commissioner Solon – yes; and Vice President Hays – yes. The motion passed 5-0.

### **Comments from Commissioners**

Commissioner Kuhl shared about a letter she had received from a citizen that complimented the operations staff.

Vice President Hays acknowledged the Leonhard Recreation Center staff for their recreation programs and shared compliments he had received regarding the strength training classes.

There being no further business to come before the Board, Vice President Hays made a motion to adjourn the meeting. The motion was seconded by Commissioner Solon. Upon roll call, the vote was as follows: Commissioner Kuhl – yes; Vice President Hays – yes; Commissioner Solon – yes; Commissioner McMahon– yes; and President Miller – yes. The motion passed 5-0 and the meeting was adjourned at 7:26 p.m.
