PURPOSE

The Champaign Park District was organized in 1911 and established as a separate unit of local government in 1955 by a referendum. The mission of the Park District is to enhance our community's quality of life through positive experiences in parks, recreation, and cultural arts.

PROFILE

Population

The Park District's population per the 2020 census is 88,302. The Park District also serves the University of Illinois population and the City of Urbana through a reciprocal agreement with the Urbana Park District.

Assessed Valuation

The estimated equalized assessed valuation for real estate for 2023 is \$2,349,889,720.

Tax Rate

The property tax rate for 2023 is 0.1759 per \$100 of assessed value.

Current Budget

The operating budget for FY 2024/25 is \$24,862,452. The fiscal year begins May 1 and ends April 30.

Staff

The Park District has an appointed Executive Director responsible for the administration of the Park District. The Park District employs 80 full-time staff and during a typical year approximately 600 part-time, seasonal, and temporary workers.

BOARD OF COMMISSIONERS & ADMINISTRATIVE STAFF

Champaign Park District is a special district of the local government with its own financial and legal responsibilities. It is governed by five elected residents of Champaign who give their services to the community.

The Champaign Park District Board of Commissioners meets twice a month to conduct the business affairs of the District. The Regular Board meetings are held on the 2nd Wednesday of the month at 5:30 p.m. and Study Session meetings are held on the 4th Wednesday of the month at 5:30 p.m. All meetings are held at the Bresnan Meeting Center, 706 Kenwood Road, Champaign, Illinois, unless otherwise posted. From time to time special meetings of the Board may be called to discuss special or emergency issues. Residents are invited to attend and are welcome to make suggestions or comments to improve the programs or facilities offered.
